PAST EVENTS.

6th April **Committee Meeting.**

From the last minutes John picked up that we should now be starting the voluntary contribution of £1.00.

Clive told us that we had approximately £200 in the current account and £1100 in the savings account with bills coming up of £525 for insurance which gives us £30,000 cover, Rates which are £500 and Electricity (the last bill had been £113). Clive was to look into getting a rate reduction as be pay full business rates.

Tim's Autochallenge was proposed as it involved cars at the clubhouse and involved no risks to Foot and Mouth as it was just about members coming down to the clubhouse which is just the same as Friday nights only with a Barbeque. The first round is due on 22nd April.

The Yorkshire Rally wanted us to marshal on the 29th September, we agreed in principle but it is still several months away and F&M needs to be sorted first.

John Roberts made a plea for all to respect the clubhouse and try and keep it clean as very often on Friday nights the first person down arrives to the mess left over from the previous week.

We also discussed the Road and Stage Rallies and agreed to keep working on them and keep them on the back burner without spending any money until we know where we are with F&M. Certain members were going to consider Stage venues and Richard and Alastair will continue to look at routes.

Gavin Smiths Charity event lacks a venue and until a suitable one can be found he can get no further on it.

GOSSIP

TIM'S AUTO CHALLENGE

The rules of Tim's Auto Challenges are as follows:-

Open to Selby & DMC club members only

To qualify for the overall trophy you must first be registered and registrations cannot be back dated.

The first round will be on Sunday the 22nd April and will run on specified dates to be arranged later for a total of 6 rounds.

The winner will be the person who scores the most points over the six rounds.

Points scoring will be 15 for 1st, 12 for 2nd, 10 for 3rd, going down to 1 point for 12th place.

Registration will cost £5.00 for adults and £2.00 for Juniors who must be accompanied on runs by their parent at all times. Entries will cost £10 per. round for adults and £5.00 per. round for Juniors.

The Penalty for touching a cone, barrier or any obstacle will be 10 seconds.

The Penalty for crossing a specified line with one wheel only will be 15 seconds.

The Penalty for not crossing a specified line will be a Washout.

The Penalty for Short cutting, or missing a section will be a Washout.

Cars must finish with at least two wheels over the finish line but not out of the box otherwise they will receive a Washout.

Competitors may start any time after the timekeeper signals you to do so.

Tim's decision is final.

SELBY & DISTRICT MOTOR CLUB RULES. LAST UPDATED APRIL 2001.

1. NAME.

The name of the club shall be "The Selby and District Motor Club" (hereinafter referred to as 'The Club').

2. OBJECTS.

The objects of the club shall be:-To further interest in motoring and Motorsport.

To provide members with information, advice and assistance on matters connected with motoring.

To watch the local administration of the laws and regulations affecting motoring and motor vehicles and to report any proposed action or scheme to the Motor Sports Association Ltd.

To promote motor competitions in accordance with the requirements of the Motor Sports Association Ltd.

To arrange tours, lectures, discussions and social and other meetings.

To afford members such benefits and privileges, as it may be possible to arrange.

To provide a meeting place where suitable refreshments and amenities are available.

3. CONSTITUTION.

The club is a Members' club.

The club premises shall be at Sand Lane, Brighton near Bubwith, Selby, YO8 7DJ.

Ladies and Gentlemen of not less than seventeen years of age shall be eligible for membership.

Membership shall consist of:-Life Members, Honorary Members, Ordinary Members and Social Members.

Life, Honorary or Ordinary members shall be entitled to compete in all events organised by the Club and shall be entitled to use and enjoy the clubhouse and its facilities. A Social member shall be entitled to use the clubhouse and all its facilities but shall not be entitled to compete in any motoring event organised by the Club.

The rights, duties and privileges of Life, Honorary, Ordinary and Social members shall from time to time be fixed by the Committee but such rights and privileges shall in no case include participation in competitions not promoted under the General Regulations of the Motor Sports Association.Ltd

The membership of the Club including Life, Honorary, Ordinary and Social members shall at no time exceed two hundred and fifty.

Every member of the Club shall, subject to these Rules and by-laws for the time being in force, be entitled to use and enjoy with the other members of the Club, the Club premises and the things therein but shall not by reason of his/her membership be under any financial liability except of the payment of his/her annual subscription.

4. MANAGEMENT.

The authority and responsibility for the transaction of the business of the Club for its management shall be vested in a Committee, who in addition to the powers and authorities by these rules expressly conferred on them may exercise all powers and do all acts in furtherance of the objects for which the Club is established, other than those hereby expressly directed or required to be exercised or done by the Club in General Meeting.

5. ELECTION OF OFFICERS AND COMMITTEE.

There may be a President and one Vice President, and the Officers of the Club shall be the Chairman, the Vice Chairman, the Secretary, the Competitions Secretary and the Treasurer. The President and Vice President (if any) and the Officers shall be elected at the Annual General Meeting of the Club and shall hold their respective offices until their successors are appointed at the next Annual General Meeting following their appointment unless they or any of them shall be removed from office by earlier resolution of a Special General Meeting of the Club. The retiring officers shall be eligible for re-election. The Committee shall consist of not less than eight and not more than fifteen members, including the officers as before defined. One half of the Committee shall form a quorum, not less than eight members of the Committee shall be elected as at the Annual General Meeting and they shall hold office for the like term and be liable for removal in like manner as the Officers as before defined. Any retiring member of the Committee, whether or not an Officer shall be eligible for re-election to the Committee. The Committee shall have power from time to time, to co-opt other members to serve thereon whether to fill a casual vacancy or not but so nevertheless that the maximum number herein before specified shall not be exceeded. Nominations for candidates for election to the Committee must be received by the Secretary not less than seven days before the Annual General Meeting, with an intimation in writing signed by each member nominated that s/he is willing to serve. Nominations of candidates shall be signed by the member proposing them. The Committee shall have the power to appoint a sub-Committee of not less than three persons to meet on its behalf in respect of any matter which is specifically referred to such as a sub-Committee.

The President and Vice President (if any) shall be entitled to attend but not vote at meetings of the Committee. Persons who are elected as officers of the Club or to the Committee shall hold office until the next Annual General Meeting of the Club unless removed by earlier Resolution of a Special General Meeting of the Club. Each officer or Committee member shall retire at the next Annual General Meeting following his/her election but shall be eligible for re-election. Any member entitled to vote at the election of an officer or Committee member and being a member of at least two year's standing, shall be capable of being elected or nominating persons for election.

6. MEETINGS OF THE COMMITTEE.

The Committee shall meet whenever summoned by the Secretary who may convene a meeting of his/her own accord, or shall do so by direction of the Chairman, or on a requisition signed by one half of the Committee.

7. ABSENCE FROM THE COMMITTEE.

Any member of the Committee who shall without sufficient reason absent him/herself from three consecutive Committee meetings will be understood to have resigned his/her position upon the Committee.

8. DUTIES OF THE SECRETARY.

It shall be the duty of the Secretary to attend in person or by deputy all meetings of the Club and all meetings of the Committee and to take minutes of the proceedings. Such minutes shall be entered in a book and presented for confirmation at the following meeting.

9. BANKING.

All monies of the Club shall be banked in the name of the Club by the Treasurer or any other person duly authorised by the Committee to be so responsible and no disbursements shall be made therefrom except in accordance with the form or forms authorised by the Committee.

10. ELECTION OF MEMBERS.

The general Committee shall elect persons to membership of the Club and shall have the power to refuse to elect persons without assigning any reasons thereto. The name and address of any person applying for membership shall, for not less than two weeks prior to the election meeting during which the Club is open to members, be displayed on the general notice board in the Clubhouse. Every applicant for membership must be nominated by a member. Membership shall be deemed to commence on the receipt by an applicant of a membership card and the payment by the applicant of his/her annual subscription together with the official joining fee. Applications of candidates for membership shall be submitted to the Secretary for placing before the Committee. Membership of the Club shall continue only for the period covered by the current subscription and members shall be subject to re-election annually by the Committee.

11. VOTING AT COMMITTEE MEETINGS.

Each member present at a meeting shall be entitled to exercise one vote. The Chairman shall not vote except in the exercise of a casting vote. The Committee shall vote by ballot. If any member present so demands a vote of one third against any application for membership shall exclude that applicant from membership.

12. SUBSCRIPTIONS.

Entrance fees and subscriptions to be fixed by the Committee and submitted as a recommendation for approval at the Annual General Meeting each year.

13. PAYMENT OF SUBSCRIPTIONS.

Annual subscriptions shall be due and payable on election and every twelve months thereafter. They shall be due and payable on the first of October in each year and shall be paid on or before the thirtieth of November in each year. The general Committee may terminate the membership of any person who fails to pay his/her subscription before the thirtieth of November. No member whose subscription is in arrears shall be eligible to take part in any competitions promoted by the Club under the General Regulations of the Motor Sports Association Ltd.

14. REGULATIONS.

Any member wishing to resign his/her membership shall give notice in writing of such a desire to the Secretary on or before the date on which his/her subscription would have become due for renewal in any year, otherwise s/he shall be liable to pay his/her subscription for the ensuing year. Also any member ceasing voluntarily or otherwise to be a member of the Club shall thereafter cease to have any claim upon the property of the Club or to enjoy any privileges of membership, but s/he shall remain liable for the payment of any debts due to the Club from him/her.

15. USE OF CLUB NAME AND ADDRESS.

The name and address of the Club shall not be given by a member as his/her address for any trade, advertising or business purposes or in connection with any legal proceedings.

16. LIFE MEMBERS.

Subscribers of not less than ten times the annual subscription for the time being, may be elected Life Members by the Committee and shall be exempt from the payment of annual subscriptions. A member cannot become a Life Member until after re-election.

17. HONORARY MEMBERS.

The Committee may elect as Honorary Members all members of Royal families and any persons distinguished for their political, scientific, literary, industrial and administrative capacities or who have been distinguished in promoting the cause of motoring in general or of the Club in particular.

18. EXPULSION OF MEMBERS.

It shall be the duty of the Committee if at any time they shall be of the opinion that the interests of the club so require, by letter to invite any member to withdraw from the Club within a time specified in such a letter, and in default of such withdrawal to submit the question of his/her expulsion to a meeting of the Committee to be held within six weeks after the date of such a letter. Members of the Committee shall be given at least seven days notice that a question of withdrawal or expulsion is to be discussed at the meeting of the Committee. The member whose expulsion is under consideration shall be given at least seven days notice of such a meeting and shall be allowed to offer an explanation of his/her conduct, verbally or in writing and if two thirds of the members present shall then vote for his/her expulsion s/he shall thereupon cease to be a member of the Club.

19. ANNUAL GENERAL MEETING.

The annual General Meeting of the Club shall be held in the month of July in each year upon a date and at a time to be fixed by the Committee. The AGM shall:-

- a) Receive from the Committee a full statement of accounts duly audited showing the receipts and expenditure for the year ended 30th September.

Receive from the Committee a report of the activities of the Club during the previous 12 months.

Elect the officials of the club.

Elect the Committee.

Decide on any resolution which may be duly submitted to the meeting as hereinafter provided.

The Committee shall have the power to summon a General Meeting of the Club to be held upon a date and at a time to be notified to each member. Such notification shall be given at least seven days prior to the intended date of the General Meeting.

Any twelve members entitled to attend and vote at a General Meeting shall have the power to join together and summon a General Meeting of members of the Club to be held upon a date and at a time to be notified to each member. Such notification shall be given at least seven days prior to the intended date of the General Meeting.

20. VOTING.

Each member present at a General Meeting may exercise one vote. The Chairman will not vote except in the exercise of a casting vote. At all General Meetings, except as provided in Rule 21, a majority of votes decides a resolution. At any General Meeting any twelve members may demand a poll, thereupon the meeting shall be adjourned to a time and place to be named by the Chairman, and a postal vote shall be taken of all members of the Club. The decision of the members, as shown by such a postal vote, shall be reported to the adjourned meeting, and shall be deemed to the decision of the meeting.

21 ALTERATION OF RULES.

Subject to confirmation by a majority of two thirds of those members present and voting at the next following General Meeting, the Committee shall have the power from time to time to alter, revise, amend or add to these Rules and pending such confirmation, such alterations, revision, amendment or addition shall be of full force and effect as if it were contained herein. Particulars of any such alteration, revision, amendment or addition shall be set forth in the General Meeting at which it is to be considered.

22 OBSERVANCE AND INTERPRETATION OF RULES.

Every member binds him/herself to abide by the Rules of the Club, and also by any modifications thereof made in conformity with such Rules, and also to accept as final and binding the decision of the Committee in all cases of dispute or disagreement as to the interpretation of these Rules.

23 EVENTS.

All motor competitions promoted by the Club shall be held under the General Regulations of the Motor Sports Association Ltd and in accordance with any other requirements of the MSA. Any member convicted of an offence arising out of his/her being in charge of a motor vehicle in any Club event or on Club business shall thereupon be liable to expulsion from the Club under Rule 18.

24 COPIES OF RULES.

Every member shall be furnished with a copy of these Rules as soon as possible and every new member on his/her election.

25 BADGES.

Any badges issued to a member by or for the Club shall remain the property of the club. On termination of their membership members shall deliver up such badges to the Secretary.

26 APPROACH TO THE CLUBHOUSE.

The speed limit on the approach shall be 15 m.p.h. All members shall approach the Clubhouse by the route indicated by the arrows, and shall not permit his/her vehicle to enter any other part of the airfield without express authority of an Official of the Club.

27 DISSOLUTION.

The Club may be dissolved by a Special General Meeting convened by direction of the Committee, or on the requisition of the majority of members. If the resolutions of dissolution be duly passed, the Committee shall forthwith liquidate the affairs of the Club and these shall be disposed of at the discretion of the Committee.

28 GUESTS.

Members may introduce and entertain friends at the Club premises and there shall be kept at the Club premises a Visitors Book in which both the member and friend should sign. The member introducing a guest must accompany him/her and be responsible for his/her guest strictly observing the Club Rules. Guests who have been introduced to the Club premises may purchase intoxicating liquor if they so wish provided the Visitors Book has been properly signed. No person shall be admitted to the Club premises as a guest on more than six occasions in any Club year.

29 INTOXICATING LIQUOR.

The supply to the Club of intoxicating liquors, not-intoxicating liquors and tobacco shall be under the control of the General Committee who shall make such arrangements for the purchase thereof as they consider to be in the best interests of the club. The supply to members shall be as directed by the General Committee and the General Committee shall have the power to decide the prices to be charged. The General Committee shall make arrangements for the keeping of accounts of all purchases and receipts and a report and financial statement shall be presented and made available to the club annually as soon as possible after the end of the club year.

Intoxicating liquor shall be supplied on the Club premises to members and guests signed in under Rule 28 during the following times:-

Monday to Saturday 11:00 – 15:00 and 18:00 – 23:00

Sunday 12:00 – 14:00 and 19:00 – 22:30

30 OPENING HOURS.

The Club shall be open and prepared to receive members from 10:00am to 11:00pm

or as directed by the General Committee.

31 BY LAWS.

The General Committee may from time to time make, vary or revoke Bye laws (not inconsistent with these Rules) for the regulation of the internal affairs of the Club and the conduct of members. Until revoked all By Laws shall be binding on the members.
