## 3 Swans Road Rally 14/15th December 2002

Thank you for your letter dated 5<sup>th</sup> November 2002 concerning the above, proposed rally. Having considered your comments I feel that I should explain more clearly what Road Rally's are and what precautions we intend to take to ensure safety of the operational railway line at all times.

Road Rally's are run at night on 'open' public roads with around 30 competitors. Standard road cars are used and the time schedule between controls is based on an average speed of 30 mph. The events are authorised by the RAC Motor Sports Association with the approval of the Police Authorities covering the route and all house owners and landowners along the route are consulted.

With regard to the level crossing at HUL1 25.1694, we propose to have a manned control immediately before the crossing where competitors will be required to stop and obtain a time at the end of a competitive section. The following section will be a non-competitive section where the time schedule is set at a lower average speed. This non-competitive section will end immediately after the level crossing at HUL1 24.1144 with another manned control. The marshals at these controls will hold competitors at the control in the event of a train approaching the crossings.

With regard to the level crossing at HUL 3 5.0748, we have obtained permission to use the unclassified road which crosses the railway line at this point from the owner UK Coal Mining Ltd. Although this is a competitive section we intend to site an intermediate time control immediately before the level crossing where competitors will have to stop.

There will be two marshals at this point, one dealing with the competitor and one checking the lights on the gate and watching for approaching trains. In the event of a train approaching the marshals will hold competitors and give them a restart time after the train has passed, this delay will be dead time and will be deducted from the overall time. When it is safe to cross the railway line the competitors will be restarted at one-minute intervals with a specific instruction to go over the level crossing slowly to avoid damage to the surface of the crossing.

I trust that the above procedures will address your concerns. However I must stress that we want to ensure the safety of the operational railway line at all times and we do not want to disrupt rail operations in any way. Therefore we will work with you to ensure that these requirements are met in full.

Selby and District Motor Club are organising the 3 Swans Road Rally on the night of 14/15<sup>th</sup> December 2002. The proposed route for the rally uses an unclassified road close to Gascoigne Wood Mine near Selby. A search of HM Land Registry records has revealed that UK Coal Mining Ltd own this unclassified road. We would therefore request your permission to use this road on our event.

I should explain that Road Rally's take place at night on 'open' public roads with around 30 competitors. Standard road cars are used and the time schedule between controls is based on an average speed of 30 mph. The events are authorised by the RAC Motor Sports Association with the approval of the Police Authorities covering the route and all house owners and landowners along the route are consulted.

The proposed route approaches the mine from the B1222 to the north. Immediately before the Entrance Gates to the mine the route would turn left on to the unclassified road which runs due East and then turns South following the perimeter fence of the mine. The road then crosses the railway line and continues towards South Milford. We are already talking to Railtrack regarding the use of the level crossing on the road and any safety requirements that they may require.

We would like to use this section of road on 14/15<sup>th</sup> December 2002 with the first car scheduled to arrive around 03:15. Competitors would then arrive at approximately one-minute intervals for the next 30 to 45 minutes. The use of the road for this event should not cause any inconvenience to your company or your employees.

With regards to your letter to Ralph Jackson dated 2<sup>nd</sup> December 2002 I can confirm that entries for the above event close at 12.00 on Monday 9<sup>th</sup> December 2002 and following this Ralph will complete the remittance slip and send it to you together with a cheque.

Please find enclosed two full sets of tracings for the finalised route following completion of PR work. There are three re-routes to the original tracings:-

- 1. Between the start TC1 and TC2 it is proposed to use the A163 through Bubwith to the B1228. The original route using the yellow road to the north of the village was proposed to avoid major road works on the A163 which have now been completed.
- 2. Between TC5 and TC6 it is proposed to turn left at the crossroads on the edge of Bishop Wilton and join the A166 at the bottom of Garrowby Hill. This will avoid going through the village.
- 3. Between TC10 and TC13 a major re-route has been necessary following PR problems in the village of Bursea. The location of the PR problems has been shown on the tracings for future reference.

The above re-routes have been notified to, and agreed by John Richardson the RLO for North Yorkshire. John has been kept informed of the PR issues and necessary re-routes as soon as they have occurred.

There are three sections of white roads proposed in the finalised route. TC4 is situated on a short track which used to be the course of an A road, before road improvements. There are houses at the start and end of the track which have been PR'd without objections, as has the owner of the land that the track crosses. The second section is a lay-by between TC18 and TC19. There are two houses at start of the lay-by which have been PR'd without objections, as has the farmer who owns the land.

The third section of white road is located between TC22 and TC23. An extensive search of the Land Registry at York revealed that the owner of the land is UK Coal Mining Ltd. When I contacted UK Coal they advised that the track was also classed as a Public Footpath and that North Yorkshire County Council should be contacted.

North Yorkshire County Council contacted the local Councillor for the area who said that they had no objection to the rally using the footpath during the night. This message was then relayed back to UK Coal who also gave a verbal agreement provided that we provided total indemnification against any claim that may arise from use of the road for the duration of the event. Having discussed this with the RLO we believe that the MSA Insurance would be satisfactory. As a further precaution we have contacted Railtrack who have given advice on safety procedures to be adopted at the level crossing at the end of the white road.

As a result of the PR work we have received three letters of complaint from residents in the village of Bursea, in addition to a verbal objection during a PR visit. As detailed earlier we have re-routed to avoid this area and informed the RLO of the exact location.
