3 Swans Road Rally 25/26th June 2005

Selby and District Motor Club are organising the 3 Swans Road Rally on the night of 25/26th June 2005. The proposed route for this navigational event uses an unclassified and non-metalled road to the north west of Carlton, as shown on the enclosed map. A search of HM Land Registry records has revealed that The Aire and Ouse Farms Ltd own part of this unclassified road. We would therefore request your permission to use this road on our event.

I should explain that Road Rally's take place at night on 'open' public roads with around 30 competitors. Standard road cars are used and the time schedule between controls is based on an average speed of 30 mph. The events are authorised by the RAC Motor Sports Association with the approval of the Police Authorities covering the route and all house owners and landowners along the route are consulted.

We would like to use this section of road on 25/26th June 2005 with the first car scheduled to arrive around 03:00. Competitors would then arrive at approximately one-minute intervals for the next 30 to 45 minutes. The use of the road for this event should not cause any inconvenience to your company or your employees.

Thank you for your letter dated 28th December 2004 outlining the proposal for a Northern Historic Road Rally Championship. The contents of the letter have been circulated to Selby and District Motor Club members and were discussed at a rally meeting on Thursday 6th January 2005. The members of the motor club voted unanimously to 'express an interest' in the Three Swans Rally being a round of the proposed championship.

In the Supplementary Regulations the number of classes has been amended to include a class for Historic cars registered before 31st December 1974, to comply with the championship regulations.
